Overhead lines pose a threat because members often forget to recognize overhead hazards. We work hard to ensure we maintain proper clearances, but there is no guarantee as lines can sag. In addition, with new aerial fiber lines being installed, previous clearances may no longer be valid. Member-caused outages can be expensive and unnecessary if the proper precautions are taken. We encourage all members to take a few extra minutes to ensure safety. Let's aim to be 100% free from member-caused outages.

We will be ramping up our spring fiber construction. Construction of new fiber will be happening in Clifton, Salem, Maiden Rock, and Kinnickinnic townships. Fiber drops to the home will be taking place in Phase 1 and 2 areas this spring and early summer before we shift our attention to Phase 3 areas. To see if your home is eligible for fiber, please go to https://connect.swiftcurrent.coop to check your address. If your home is eligible, you can sign up for service. Within a couple of days, our customer service team will reach out to complete your paperwork and send instructions on making a payment to cover your installation.

### UNDERGROUND INSPECTIONS BEGIN IN JUNE




## WATCH YOUR ENERGY BILL FOR CAPITAL CREDIT ALLOCATION NOTICES

The notice for 2022 capital credit allocations will be inserted with your energy bill arriving in May and June. For members enrolled in paperless billing, the allocation notice will be available with your energy statement in SmartHub.

Allocations determine each member's share of the cooperative's margin for a given year. Margins are allocated or assigned to members who purchased electricity from the cooperative during the year in which the margin was generated in proportion to the electrical sales for the year. Each member's allocation is determined by his/ her kilowatt-hour consumption for the year. The co-op keeps a permanent record of each member's capital credit account, which is where the allocated amount remains until it is paid or "retired."



What are capital credits? Capital credits are a major benefit of belonging to a cooperative. As a cooperative, we're owned by our members. Unlike other electric utilities, your cooperative is a not-for-profit organization. Any revenues (margins) remaining after expenses have been paid are allocated to our members as capital credits that are determined based on each member's share of electrical costs and purchases for the year. ## **MAY IS ELECTRICAL SAFETY MONTH** Look up for power lines and stay safe

Things that we see every day may go unnoticed. In fact, studies show that our minds likely ignore power lines. They are so much a part of our everyday landscape that we don't even see them anymore. Unfortunately, the failure to notice high-voltage power lines can be a deadly mistake.



According to the U.S. Consumer and Product Safety Commission, hundreds of consumer deaths occur each year from direct or indirect contact with power lines. Electrocution is also the second leading cause of death for utility and construction workers, according to the National Institute of Occupational Safety and Health.

With spring-like weather comes a boost in outside activities, a perfect time to know your surroundings, and look up for power lines to keep you and your family safe. Consider these guidelines when playing and working outside:

Report electric outages through SmartHub or call 800-927-5705.

Report internet outages by calling 866-307-5326.

- Look up and around you. Always know the location of power lines, particularly when using long metal tools like ladders, pool skimmers, and pruning poles. Lower your long equipment when you are moving it. Carry ladders and other long items horizontally whenever possible.
- Be careful when working on or around your roof, installing rooftop antennas and satellite dishes, doing roof repair work, or cleaning gutters. Never go up on the roof in bad weather.
- Be especially careful when working near power lines attached to your house. Keep equipment and yourself at least 10 feet from the lines.
- Never trim trees near power lines. Never use water or blower extensions to clean gutters near electric lines. Leave these jobs to the professionals.
- Never climb trees near power lines. Even if the power lines are not touching the tree, they could touch



when more weight is added to the branch.

• If your projects include digging, like building a deck or planting a tree, call Digger's Hotline at 811 before you begin to locate underground utility lines. The service is free, prevents utility services from being interrupted, and can help you avoid serious injury or death.
